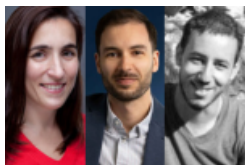
partners and the research community. This event will follow the annual meeting of CIRANO researchers.

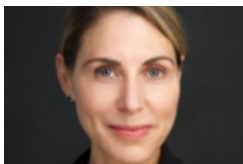
The CIRANO team is growing!

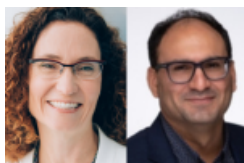
2023 Report on the Representation of Women Economists in Canada's Universities by Erin Strumpf
